

Terms & Conditions

By entering this Promotion, you agree to be bound by these Terms and Conditions ("**Terms & Conditions**") and to comply with all applicable laws and regulations.

1. This promotion, named "Gaming Made Cooler" (the "**Promotion**") is organized by Acer Sales & Services Sdn Bhd ("**Organiser**").
2. The Promotion shall run from 1st November 2017 to 31st December 2017 (both dates inclusive) (the "**Promotion Period**"). The deadline for redemption shall be by 6.00PM on 5th January 2018.

A. ELIGIBILITY

1. In order to be eligible to participate in the Promotion, the Participant must satisfy the following:
 - A resident of Malaysia, except as per clause 2 below;
 - If the Participant is below eighteen (18) years of age, the Participant must obtain the appropriate permission and release from a parent or legal guardian in order to participate in the Promotion; and

Step 1 Purchase any Eligible Acer Product as per Clause 3 from any Acer Authorized Retailer.

Step 2 Log on to (<https://www.a-redemption.com/>) and fill up the e-redemption form. Upload a

copy of the original receipt or invoice as proof of purchase. The latest date and time of redemption must be received by the Program Centre by 6.00PM on **7th January 2018**.

- The Participant must provide the requested personal information when filling up the e-redemption form. Incomplete submissions will be discarded without prior notice. An incomplete submission is a submission which incomplete redemption and contest form, without proof of purchase, and/or have incomplete details in the proof of purchase (without purchase item, quantity, serial number, invoice number, or invoice date).

22. Charges for 3rd-party collection, delivery, insurance, etc. will be imposed to recipients who fail to receive the gift either by means of address error by the recipients, or is physically absent during delivery, or choose to make special collection arrangements or pick-up services.

23. Gifts that are not delivered successfully after 3 (three) attempts will be forfeited without prior notice.

25. 32. All participants shall be responsible for ensuring that such disclosures are in compliance with the provisions of Malaysia Personal Data Protection Act 2010.

33. You may notify the Organiser of any updates, amendments and corrections to previously collected information via the Organiser's website.
34. The Organiser and its parent company may also use your personal data to communicate with you about its products and services, update you on new services and benefits, provide personalized promotional offers and allow you to participate in contests and surveys. In this regard, your personal data may be disclosed and transferred to the Organiser's service providers, suppliers and/or affiliates which may or may not be located outside Malaysia. If you have any complaints, comments or questions on this Privacy Notice, or wish to access or correct your personal data, or limit our processing of the same, please contact the Organiser.

G. GENERAL CONDITIONS

34. Limitation of liability. To the maximum extent permitted by law, the Organiser and its parent company, affiliates, related corporations, subsidiaries, directors, officers, employees and agents accepts no responsibility whatsoever for any liabilities of any kind for any damage to any property that may occur as a consequence of your participation in the Promotion.
35. Indemnity. To the maximum extent permitted by law, you undertake to indemnify and keep the Organiser and its parent company, affiliates, related corporations, subsidiaries, directors, officers, employees and agents harmless and indemnified against any loss, damage, claims, costs and expenses which may be incurred or suffered by any or each of them due to your breach of any of these Terms and Conditions and/or arising from your participation in the Promotion, and/or your use of any gift.
36. The Organiser's decision is final and binding. 41. All information is correct at the time of publishing. In the event of any inaccuracy or any discrepancy between the print and online versions, the online version shall prevail over the print version.
42. Severability. Each of the provisions of these terms and conditions apply to the maximum extent permitted by applicable law. If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the rest of these Terms and Conditions will remain in effect and

these Terms and Conditions will be amended to give effect to the eliminated provision to the maximum extent possible.
